ORDER

Whereas **M/s. Sant Harbhajan Social Welfare Society** was granted permission authorizing the Society for imparting two days refresher training course for driver and conductors badge including HMV.

Whereas several complaints were received about improper functioning of M/s. Sant Harbhajan Social Welfare Society.

Whereas complaints were forwarded to a Committee constituted for the purpose of examination of the contents of the complaint.

Whereas the Committee has submitted its report on 14/03/2016 concluding :

- A. Permission for the establishment of institute for imparting instructions in Driving respect of all types of motor vehicle to M/s. Sant Harbhajan Social Welfare Society have flaws on the following grounds;
 - a) The licence under the provisions of Rule 24 & 25 does not seem to abide by the Institute.
 - b) No proof regarding payment of requisite application fee paid by the institute is available on file.
- B. The authorization issued to M/s. Sant Harbhajan Social Welfare Society for conducting refresher course for PSV badge for drivers seems to be in violation of the guidelines issued in this regard.
- C. The authorization issued to M/s. Sant Harbhajan Social Welfare Society for conducting refresher course for PSV badge for conductors seems to be in violation of the guidelines issued in this regard.
- D. The authorization issued to M/s. Sant Harbhajan Social Welfare Society for conducting refresher course for PSV badge for drivers of commercial vehicle (including HMV) seems to be in violation of the guidelines issued in this regard.



In view of the considering the findings of the Committee and approval of the Worthy Commissioner, Transport, **the authorization granted to M/s. Sant Harbhajan Social Welfare Society for imparting two days refresher training course for drivers and conductors badge including HMV is hereby suspended with immediate effect.**

M/s. Sant Harbhajan Social Welfare Society, if aggrieved with the above orders may prefer an appeal under the provisions of Rule 27 to 29 of CMVR 1989, if so desired.
