

Sub : Adoption of the Central Civil Services (Revised Pay) Rules, 2016

Finance Department, GNCTD of Delhi vide letter No.F.(21)/Fin. (Est.!!!)/07CPC/2016/dsv/870 dated 16.08.2016 has forwarded copies of Notification/Resolutions/OMs issued by Govt. of India in connection with decision of Govt. of India for Adoption of Central Civil Services (Revised Pay) Rules 2016. 
