ORDER

1. Whereas, an application dated 09.05.2013 for grant of licence to engage in the business of imparting instructions in the driving of the motor vehicles i.e. Motor Car and Motor Cycle was filed by Sh. Sukhminder Singh proprietor of M/s. New National MDTs. The application under reference was examined as per the prevalent guidelines and the provisions of the Motor Vehicle Act the rules made thereunder.

2. And whereas, several deficiency memos were issued by the concerned Motor Licensing officer to make up the deficiencies.

3. And whereas, a team of Inspectors visited at the proposed premises for inspection to assess the feasibility and availability of infrastructure but it was found locked. The applicant was contacted on his mobile and he requested for two weeks' time for re-inspection. Accordingly, the applicant was apprised vide this office letter dated 01.04.2016 to inform immediately whether the premises is ready for inspection so that inspection could be arranged.

4. And whereas, a last opportunity was given to the applicant vide letter No. SMV/MLO/TPT/2016 /MISC/2879 dated 16.09.2016 to get the proposed premises inspected within 7 days where Motor Driving Training School is to be established with the directions that no further communication will be made in case he failed to reply within given period and the application shall be rejected.


5. And whereas, no reply/response has been received by the office of Motor Licensing Officer (EZ-II) till 13.10.2016 from the applicant.

6. And whereas, the Motor Licensing Officer (EZ-II) has examined the matter and found that the applicant/MDTS does not comply with the provisions of rule 24, 25 and 27 of the Central Motor Vehicles Rules and the prevalent guidelines.

7. Now, in the light of above observations, the application/representation of Sh. Sukhminder Singh proprietor of M/s. New National MDTs for grant of licence to engage in the business of imparting instructions in driving of motor vehicles is hereby rejected.


