Sub – Use of City Compost - regarding

Whereas, a policy on 'Promotion of City Compost' is notified vide OM F.No.11026/14/2015-M&E dated 10.2.2016 by Department of Fertilisers, Ministry of Chemical and Fertilizers, Govt. of India.

Whereas, the said policy provides for Market development assistance in the form of fixed amount of Rs. 1500 per tonne of City Compost for scaling up production and consumption of the product. The Ministry of Urban Development will take steps to increase setting up of compost plants across all States and Ministry of Agriculture will carry out IEC campaigns to educate farmers on the benefits of city compost. The fertilizer companies and marketing entities will co-market City Compost with chemical fertilizers through their dealers' network. The product is also being promoted under the "Swachh Bharat Abhiyan" campaign of Govt. of India launched by the Hon'ble Prime Minister.

Whereas, as per para 1(vi) of the notification of the policy, Government Departments and public sector undertakings will also use city compost to the extent possible for their horticulture and related use.

Whereas, subsequent to notification of the policy, the tagging of Cities where fertiliser/ composting/ waste-to-compost plants are operational with fertiliser marketing companies for the purpose of proper utilisation of City Compost produced in the cities has been completed for Delhi.

Whereas, National Fertilizers Limited has been tagged as Marketing Company for Marketing of Compost generated by three plants located in Delhi, under jurisdiction and administrative control of Municipal Corporations.

Whereas, the fertilizer company has assigned tripartite agreement with concerned compost manufacturer/municipal commissioner

Whereas, an OM No.11026/7/2016-M&E dated 22.2.2016 by Department of Fertilisers, Ministry of Chemical and Fertilizers, Govt. of India requires Government Departments and public sector undertakings to also use city compost to the extent possible for their horticulture and related use.

Whereas, a State level Steering Committee has been constituted for promotion of the scheme vide office memorandum F.No. 11026/26/2016-M&E dated 10.5.2016 by

Department of Fertilisers, Ministry of Chemical and Fertilizers, Govt. of India with Principal Secretary/Secretary, D/o Urban Development (Local Self Government) as the Chairman.

GNCTD in pursuance of the term of reference in the said OM direct the user departments and organisations under GNCTD to use the city compost, that would be marketed by NFL, to the extent possible for their horticulture and related use and intimate the action taken/compliance report.
