CIRCULAR

Sub.:- Declaration of assets and liabilities by public servants under Section 44 of the Lokpal ad Lokayukta's Act, 2013.

As per provision of Section 44 of the Lokpal and Lokayukta's Act, 2013 (reproduced below) every public servants is required to furnish information relating to his/her assets and liabilities to the Government as per time schedule fixed in the Public Servants (Furnishing of Information and Annual Returns of Assets and Liabilities and the Limits for Exemption of Assets in filing Returns) Rules and Lokpal & Lokayuktas (Removal of Difficulties) Order, 2014.

Section-44:- (1) Every public servant shall make a declaration of his assets and liabilities in the manner as provided by or under this Act. (2) A public servant shall, within a period of thirty days from the date on which he makes and subscribes an oath or affirmation to enter upon his office, furnish to the competent authority the information relating to- (a) the assets of which he, his spouse and his dependent children are, jointly or severally, owners or beneficiaries; (b) his liabilities and that of his spouse and his dependent children. (3) A public servant holding his office as such, at the time of the commencement of this Act, shall furnish information relating to such assets and liabilities, as referred to in subsection (2), to the competent authority within thirty days of the coming into force of this Act. (4) Every public servant shall file with the competent authority, on or before the 31st July of every year, an annual return of such assets and liabilities, as referred to in sub-section (2), as on the 31st March of that year. (5) The information under sub-section (2) or sub-section (3) and annual return under sub-section (4) shall be furnished to the competent authority in such form and in such manner as may be prescribed. (6) The competent authority in respect of each Ministry or Department shall ensure that all such statements are published on the website of such Ministry or Department by 31st August of that year. Explanation .-- For the purposes of this section, "dependent children" means sons and daughters who have no separate means of earning and are wholly dependent on the public servant for their livelihood.

As per O.M. No. 407/12/2014-AVD-IV(B) dated 11.10.2015 issued by Ministry of Personnel Public Grievance and Pension, DOPT, GOI, as forwarded by Services Department, GNCT of Delhi vide letter No.F.C/Misc./290/2012/SI/4164 dated 09.12.2015, communications on extension of last date for filing of revised returns for the year 2014 (as on 01.08.2014) and the returns for the year 2015 (as on 31.03.2015) by Public Servants from 15th October 2015 to 15th April, 2016 has been received which are enclosed for ready reference and compliance.

All officers/officials of the Department are directed to ensure compliance with the revised Rules within the revised time-limit mentioned therein.
