ORDER

No.60(198)/DWCD/ADWEC/LCC/2014-15 .--In exercise of the powers conferred by section 5 of The Sexual Harassment of Women at Workplace (Prevention, Prohibition And Redressal) Act, 2013 (No. 14 of 2013), the Government of National Capital Territory of Delhi hereby nominates the District Magistrate of every District as "District Officer" to exercise the powers and discharge the functions under this Act in the National Capital Territory of Delhi.

The "District Officer" of every district shall constitute "Local Complaint Committee" under section 06 of the said Act to receive complaints of sexual harassment from establishment where the "Internal Complaint Committee" has not been constituted due to having less than ten workers or if complaint is against the employer himself.

The District Officer shall designate one nodal officer in every ward/ municipality to receive complaints and forward the same to the concerned Local Complaint Committee within a period of seven days.

The jurisdiction of Local Complaint Committee shall extend to the areas of the district where it is constituted.

The District Officer will discharge all the functions and powers in accordance with the Act.
