The Special Director (RTI), WCD apprised the facts of the case. It was informed that the applicant Mahender Arora had supplied furniture to the respondent authority i.e Deptt. of Social Welfare (before it was bifurcate nine years ago but till date has not received any payment for the furniture items purchased from Kendriya Bhandar against the purchase order 28.02.2007.

The applicant has sought information regarding details of the payment made thereof.

The CIC has directed the CPIOs of the Deptt. of Social Welfare and WCD to furnish the above information and the reason for delay.

"The Commission directs the CPIOs of Social Welfare and Women & Child Development Departments to furnished the information sought, when they will be making payment along with interest, why it was delayed for more than nine years, who is responsible for this and explain why both of these departments should not be directed to pay compensation to the appellant within 21 days from the date of receipt of this order".

Sh. P.V Gangadharan, Accounts Officer, WCD suggested that the payment details can be sought from the bill control register and the stock register of place of safety / SHP. Dr. Ramvir Singh, Supdt. (POS/SHB), WCD informed that the cash book and bill register were seized by Anti Corruption Department and therefore the department isn't in a position to divulge the clear status of payment as claimed by the Appellant.

The concerned PIO is directed to inform the CIC regarding the Non-availability of records as the same is seized by Anti Corruption Department.

Concerned branch / officer is directed to follow-up the status of the seized records with the Anti Corruption Cell.
