ORDER

Department of Women and Child Development which is processing the proposal for amendments in the Recruitment Rules of the Post of Welfare Officer/Probation Officer/Prison Welfare Officer of the Department of Social Welfare, Central Jail and WCD, had placed the proposed amendments in the RRs of the Posts in the form of ANNEXURE-I on the web site of the Departments seeking objections/comments from all stakeholders vide letters 26.04.2016 and 28.04.2016 respectively.

With reference to the same the Departments received objections from Welfare Officer, House Father/Mothers/Matrons and Care Takers. Such objections were processed and submitted to the competent authority for decision. The Competent authority after considering the objections has agreed to dispose of the objections, as per comments of the Department in table below:-

Objections raised by	Brief of Objection	Comments of Department
Welfare Officer	For grant of pay scale GP 4800/- to the post of Welfare Officer in the Amended RRs.	In the proposed amendment, the Pay Band and GP is not being changed, as such the objection is uncalled for.
House Father/Mother/Matrons	For reducing the condition of 10 years qualifying service in feeder grade (GP 2400) for eligibility for promotion to the post of WO (GP 4200) as five years.	As per DOPT instructions for promotion to the posts in GP 4200/- from feeder cadre posts of GP 2400/-, the prescribed qualifying service is 10 years, as such the objection for keeping the period of qualifying service as 5 years is not acceptable.
Care Takers	Inclusion of the post of Care Taker (Erstwhile Group D) in the feeder cadre for promotion to the post of Welfare Officer.	As per DOPT instructions posts with GP of Rs. 1800/- or 1900/- cannot be the feeder cadre posts of posts carrying GP of Rs. 4200/- as such the objection is not acceptable.
