

INTRODUCTION


hildren need a safe and nurturing environment for optimum, healthy and overall growth and development. As far as possible, children should stay with their families in a stable, safe, secure, loving and protective environment. When families become dysfunctional, incapacitated or unsafe for their children, children are the worst affected as they go astray, are left uncared, unprotected, exposed to vulnerable situations leading to their abuse, harm or rendering them homeless. Here, intervention is required to ensure that the children are immediately reached out and put in a safe and secure place for their overall well being – physical or emotional. Protecting children from all forms of neglect, violence, abuse, crime and exploitation in different settings, including family, community and wider society is essential to ensure that they lead a happy, healthy and cheerful life.

"Child Protection " is about creating a "protective environment" for all children which calls for a coordinated effort of all stakeholders including the Government, communities, schools, hospitals, judiciary, police, NGOs and responsible citizens to protect children against all forms of neglect, violence, abuse, exploitation. The main essence of child protection is to ensure that no child falls out of the social security and safety net and those who do, receive necessary care & protection to be brought back in to the safety net.

The existing institutions and programmes for child protection in India emanate from the provisions under the JJ Act 2000. ICPS brings several existing child protection programmes under one umbrella. The scheme visualizes a structure for providing services as well as monitoring and supervising the effective functioning of child protection system. The Integrated Child Protection scheme of the MWCD, GOI launched in 2009 aims at addressing the issues concerning child protection clearly based on certain guiding principles which include:

- ✓ Child Protection as primary responsibility of family
- ✓ Support by community
- ✓ Government and Civil Society
- ✓ Loving and caring family as the best place for the child
- ✓ Child privacy and confidentiality
- ✓ Non stigmatization and non discrimination
- ✓ Prevention and reduction of vulnerabilities as central to child protection outcomes

- ✓ Institutionalization of children as last resort
- ✓ Code of conduct
- ✓ Accountability and responsibility
- ✓ Transperancy



The Integrated Child Protection Scheme contributes to the realization of Government / State responsibility for creating a system that efficiently and effectively protects children. . It is based on two main principles of "protection of child rights" and "best interest of the child".

The ICPS Scheme In Delhi.....

To implement the ICPS scheme in the state of Delhi, the State Child Protection Society, Delhi came into existence in 2010 and has initiated important programmes with regard to making services accessible/ available to the beneficiaries as per the ICPS guidelines & JJ Act / Rules. On an average, about 8000 children are attended to, annually through different schemes and programmes of ICPS at the State / District level.

To meet the objective of ICPS, the SCPS works through a collaborative effort with all the concerned agencies, departments and stakeholders to ensure that the children in dangerous and difficult circumstances are provided immediate attention and prevented from falling in to harmful situations and exploited.

The umbrella programme ensures that all children from diverse backgrounds are taken care of in a protective environment through an organised and systematic procedure.



AN OVERVIEW OF THE PROGRAMMES AND ACTIVITIES INITIATED BY SCPS, DEPARTMENT OF W&CD, GNCTD

Since its inception, The State Child Protection Society has made the following interventions to implement the ICPS scheme and facilitate the process:

1. Release of Grant-in-Aid under the Centrally Sponsored Scheme "Integrated Child Protection Scheme": Financial support is provided for setting up of homes, maintenance and up gradation of homes for children in need of care and protection and children in conflict with law.

As a regular procedure, Grant in Aid is released through SCPS to various service delivery structures / statutory bodies, NGO's for running Shelter Homes under Institutional Care, NGOs running Specialised Adoption Agencies under Non Institutional Care, Open Shelters for children in need of care and protection in urban and semi urban areas under ICPS.

2. Online submission of Central Level Monitoring Reports: Quarterly monitoring reports of ICPS are submitted online to the Ministry of WCD, GOI. The entire process of compilation and submission has been streamlined by the ICPS Unit, DWCD by ensuring timely submission of monthly & quarterly reports from CWCs, JJBs, Government run CCI's, NGO run CCI's and Specialised Adoption Agencies (SAA's) in the prescribed format. Reports of all four quarters for the year 2014-15 have been submitted to the MWCD, GOI

To avoid delay of submission of reports, all CCI's and agencies have been issued strict orders by the Department with regard to submission of the monthly and quarterly report within the first ten days of the month. Updated status is uploaded on the Departments website: www.wcddel.in

The SCPS (ICPS Unit) has conducted training programmes for all CCI's, CWC staff on filling up of relevant information in the prescribed format and clarifications were sorted out by ICPS team on difficulties faced by staff.

3. Carrying out periodic inspection of homes, NGO run open shelters, shelter homes to ensure better care and quality services to the children and efforts are made by the NGOs / CCIs to improve the quality of services delivered in accordance with the provisions as laid down in Acts / rules of JJ Act 2000 Issues

Night inspections of NGO run open shelters are also carried out by the ICPS team & DCPU staff to ensure that the street, homeless children are provided proper shelter, beds, beddings in the bone chilling winter weather and have access to all the basic / essential services as per ICPS guidelines of care and protection of children.

- **4.** The ICPS Unit, Department of WCD is constantly networking with stakeholders, Govt. agencies and NGO's to ensure that children on the streets are reached out and provided the safety / security net and prevent them from falling prey to anti social elements and getting trapped in dangerous situations. The Department of WCD has sought the cooperation of Delhi Police in referring any vulnerable, homeless child visible on the streets during day /night to the nearby open shelters for timely care, relief, respite and rehabilitation. In this regard a comprehensive list of all NGO run open shelters have been shared with the SHO's, Delhi Police so that prompt efforts are instigated for children in "difficult situations".
- **5.** Awareness, orientation, training/ sensitization programmes are organized for members of Child Welfare Committee, functionaries of Govt. and NGO run CCI's, the District Child Protection Officers and their supporting staff in the DCPU's on:
 - a) Protection mechanisms available for children exposed to vulnerable situations.
 - b) Timely restoration and rehabilitation of children.
 - c) issues of care and protection of children, various legislations, child mental health/child psychology
- **6.** Keeping in mind the objective of creating a protective environment for children in the State, the State Child Protection Society, Delhi has taken the initiative of issuing Public Notices in the leading National Newspapers on "PROTECTION OF A CHILD FROM SEXUAL ASSAULT, AND SEXUAL HARASSMENT "with the main objective of sensitizing the public, stakeholders and institutions- school, hostels, child care institutions and hospitals on mandatory reporting of an offence committed or likely to be committed to the local police / SJPU / Child Welfare Committee immediately

Awareness/ sensitization programmes are organized by the District Child Protection Units in communities, schools and NGO's on protection of children from sexual abuse, "safe touch & unsafe touch", protection mechanisms for children, child rights, education and legislations for children

7. Proposals invited through EOI from NGO's for new Open Shelters to be funded under ICPS Scheme of the MWCD, GOI: In response to the EOI floated in the leading newspapers for open shelter project under ICPS scheme, proposals had been received from 27 NGO's in Delhi. The proposals submitted were reviewed by a selection committee followed by an inspection visit to all the 27 NGOs by an inspecting team.

The inspections were made, based on the following broad criteria:

- i) Status of baseline survey
- ii) Existing infrastructure to run the proposed open shelter project
- iii) Staff structure
- iv) Project sustainability
- v) Current projects and services for the children of the organization

The findings of the inspecting team were further evaluated by an Evaluation/ Selection Committee which identified four NGO's for financial assistance under ICPS Scheme of GOI:-

- A) Society For Promotion Of Youth & Masses (SPYM)
- B) Abhivyakti Foundation
- C) SATHI
- D) Salaam Baalak Trust (SBT)

The M/O WCD was apprised of the shortlisted NGO run open shelters and requested to release funds for the current financial year under ICPS.

8. National Web Portal (Track the Missing Child):

The State Child Protection Society, through a collaborative effort with National Information Centre (NIC) has facilitated the process of online entries of missing and found children. Training programmes have been organized by DWCD in this regard with the assistance of NIC.

The State Child Protection Society in collaboration with NIC has initiated the process of generating user IDs and password for all the child care institutions. All child care institutions have been directed to make regular entries of children on the portal.

9. The District Child Protection Units under ICPS scheme, play a proactive and vital role at the district level in reaching out to all children in dangerous / difficult circumstances, in need of care, protection and rehabilitation. Apart from the roles and responsibilities of DCPU as laid down in the ICPS scheme, special endeavors have been initiated by the DCPU's on a massive scale to fulfill the objective of bringing the children under a protective coverage through timely and prompt intervention. Linkages are developed by the DCPU's with stakeholders to discuss and plan important child protection, welfare and rehabilitation programmes to be initiated in their respective districts.

<u>A Glance At Few Of The Special Activities</u> <u>Initiated By DCPU's:</u>

Identification of hotspots with concentration of children in to begging mainly at traffic signals, market areas and temples. The parents of the children identified, are counselled and motivated to send their children for enrolment in NFE classes and lifeskill training which is carried out in collaboration with police, CWC's, NGO's & NSS volunteers.

Organising camps for identification of lost / missing children during festival seasons like navratras, chhath puja at the temple sites and places of worship and re-uniting the lost children with their families. These camps are organised in association with Police, CWC's, NGO's and NSS volunteers from colleges.

On the basis of the information received from other sources, the DCPU along with the Delhi Police had successfully busted a child trafficking racket run by an NGO, Rashtriya Janhit Jansewa Sansthaan located in Dwarka, South West Delhi. In the operation, the DCPU team and police were able to nab and arrest three persons of the NGO and rescued a two year old child who was being trafficked. The matter is under investigation.

Rescue and rehabilitation of child labourers employed in a utensils shop in Najafgarh was done by DCPU and Delhi police followed by the production of children before CWC for their rehabilitation and restoration. The rescue operation was conducted by DCPU, West & South West on the basis of the information received by the Department from various sources.

Identification of unlicensed Child Care Institutions in the respective districts bring the matter to the notice of the Department for further necessary action.

In response to a report published in the newspaper regarding a 12 year old child with physical disability suffering burns outside AIIMS, the DCPU- South & South East reached out to the child in need of immediate medical care, shelter & attention. The following steps were initiated:

- * DCPO met the concerned doctors from where the child had was undergoing treatment, sought a suitable date & time from the neurosurgery deptt for the childs surgery and got the levied charges exempted for surgery
- * Ensured that the family gets temporary accommodation in the dharamshala nearby AIIMS during the bone chilling winter season till their child was underging treatment in AIIMS.
- * Providing wheel chair to the child through an NGO so that his parents could move him around easily instead of lifting him up everytime.

PROGRAMMES AND ACTIVITIES OF THE STATE CHILD PROTECTION SOCIETY (SCPS) DURING THE YEAR 2014-2015

A. GRANTS-IN-AID FOR THE YEAR 2014-2015 UNDER THE CENTRALLY SPONSORED SCHEME NAMELY "INTEGRATED CHILD PROTECTION SCHEME:

Under the ICPS, financial assistance from the Central Government is disbursed to the State Government/ UT Administration. The State/UT in turn provides Grant-in-Aid to voluntary organizations under the different components of the scheme which are as follows:-.

Shelter Homes:

The Juvenile Justice (Care and Protection of Children) Act 2000 empowers State Governments to recognize reputed and competent voluntary organizations, which cater to the needs of children without parental care, run away children, migrant children, etc. The State Government provides financial assistance to set up and administer Shelter Homes for such children. The Shelter Homes offer day and night shelter facilities to the children in need of support services for a temporary period, while efforts are made to rehabilitate them. The State Child Protection Society (SCPS) has released maintenance grant to 8 NGO run Shelter Homes for the financial year 2014-15.

Open Shelters:

The open shelter programme is meant to cater to a large numbers of homeless children, pavement dwellers, street and working children and child beggars who are left on their own and are in need of constant care and support. The GIA (Central Share & State Share) was released to 15 NGO run open shelters for the financial year 2014-15.

Specialised Adoption Agency (SAA):

The latest amendment to the Juvenile Justice (Care and Protection of Children) Act 2000 (as amended in 2006) provides that the State Government shall recognise one or more of its institutions or voluntary organisations as Specialised Adoption Agencies in such manner, as may be prescribed, for the placement of orphaned, abandoned or surrendered children for adoption in accordance with the provisions of the various guidelines for adoption issued from time to time, by the State Government, or the Central Adoption Resource Authority and notified by the Central Government.

The GIA (Central Share & State Share) amount sanctioned by GOI, MWCD against full and final installment has been released to 03 NGO run Specialised Adoption Agencies for the financial year 2014-15.

B. MONITORING AND EVALUATION:

Periodic inspections / monitoring visits are conducted by the SCPS team and DCPU staff of NGO run open shelters, shelter homes, adoption agencies, CCIs with the objective of reviewing the programme, status of beneficiaries catered to through the services and on the basis of the observations made and interaction held with the staff, suggestions are made with regard to areas for improvement and the necessary action to be taken by the agency for ensuring better/ quality care and delivery of services to the children.

The DCPU team has also initiated the process of identifying, visiting and listing of unlicensed child care institutions in their respective districts and bringing the matter to the notice of the Department which further directs the NGO's to apply for license as per the norms of JJ Act 2000.

C. ONLINE SUBMISSION & SHARING OF THE CENTRAL LEVEL MONITORING OUARTERLY REPORTS WITH MWCD:

Data of children placed under institutional care in Govt. & NGO run recognized CCI's are received and submitted online in the M/O WCD website on regular basis in the prescribed format.

Quarterly monitoring reports of ICPS for the period 2014-2015 have been submitted online and the process has been streamlined by ensuring timely submission of monthly & quarterly reports from all the NGOs and Government run institutions, CWCs and JJBs.

Follow up with regard to timely submission of reports to the State Child Protection Society is done regularly by the SCPS team with all the institutions to ensure that monthly and quarterly reports as per ICPS format is submitted on time. The SCPS team had also initiated the process of organizing orientation training of CCI staff on ICPS Central Level Monitoring Formats with the objective to overcome the discrepancies reflected in the data submitted to the Department.


D. PROGRESS WITH REGARD TO THE MODEL HOME PROJECT:

The Department of Women & Child development had initiated the project" Renovation of children home at Lajpat Nagar in to a Model Home" in November 2012 under the Integrated Child Protection scheme of MWCD, GOI.

PWD had submitted an estimate for the above mentioned task amounting to Rs. 2,27,01,300/- for upgrading the existing infrastructure. The Department has released an amount of Rs. 1.35 crores (Rs. 75 lacs from Integrated Child Protection Unit and Rs. 60 lacs from Delhi Govt. PWD Fund) to Public Work Department of Delhi Government. The second installment amounting to Rs. 75.00 lakhs for the project has been released by the Ministry of WCD and the amount is available with the SCPS which shall be released as per procedure.

- The repair / renovation work is under progress and regular meetings have been held by the senior officials of the Department along with PWD engineers-civil and electrical to discuss and finalize the following issues:
 - Finalising color scheme / floor design of dormitories and corridor
 - Layout of the playground
 - Interiors and electrical fittings of proposed workshop
 - Arrangement of furniture and finalization of kitchen design and equipments
 - Pruning of trees at the site
 - Speeding up of the work


F. STATUS OF OPEN SHELTERS IN DELHI:

In metropolitan cities like Delhi, it is a matter of great concern to provide for the growing needs of the children on streets, working children, children in to rag picking, child beggars and children exposed to vulnerable situations. Under the ICPS scheme, the open shelter programme provides a space for children where they can play, use their time productively and engage themselves in creative activities through music, dance, drama, yoga & meditation, computers, indoor and outdoor games, etc. Financial assistance is provided through the State Government/UT Administration to the voluntary organizations for establishing such Open Shelters.

Objective: The objective of the open shelter programme is to attract the target group of children from their present vulnerable life situation to a safe environment through sustained interventions.

The Open Shelter programme funded under the ICPS scheme aims at catering to the unique needs of these children with the main objective of protecting them from abuse, neglect and exploitation through timely intervention and provide them access to all the essential services that they require for their well being, care and security.

The following categories of children are catered to through the open shelter programme under Integrated Child Protection Scheme:



The State Child Protection Society as part of the ICPS scheme, provides financial assistance to NGO's for running open shelters and reaching out to vulnerable children through their outreach services and contact points.

All the open shelters are regularly monitored by the SCPS and DCPU team to assess and review the programme keeping in mind the well being of the children and ensure that quality of services are provided to them through the open shelters. Any shortcomings reflected during the visit are brought to the notice of the open shelter staff with directions to work on areas that need improvement followed by submission of compliance report.

The Department has taken a serious view on agencies not complying with the directions to improve upon the areas which require prompt intervention and has closed down three open shelters on account of their casual approach towards the programme, welfare of children and not adhering to the guidelines.

Main features of the open shelter programme:

- ❖ Community based safe spaces which provide a space for children where they can play, study, use their time constructively
- ❖ A safe environment where children engage themselves in creative activities through music, dance, drama, yoga and meditation, computers, indoor & outdoor games.
- ❖ Open Shelters have provisions for health care, basic nutrition, and flexi time education and vocational training
- ❖ Providing space to children where they can safely keep their belongings and earnings
- Providing them counseling, guidance and life skill education for channelizing their energy in to productive endeavours
- ❖ To make them self reliant, aware, empower them and wean them away from socially deviant behaviour

Through the meetings held with NGO run open shelter functionaries, emphasis is laid upon:

- 1. Status of children on streets during winter season
- 2. Steps initiated for arrangement of proper shelter for children at night and to ensure their safety & security
- 3. Production of children in need of long term care, rehabilitation and protection before CWC by the open shelter staff and timely submission of reports / details of children to the Department with the objective to ensure that no child falls out of the safety net.
- 4. Strengthening of outreach services during night by the open shelter staff with the objective to reach out to "many "more children in need of care, protection, shelter and safety.

The CWC is entrusted with the power to seek a detailed report or pass a direction for production of a child in any of the cases as may be required for further inquiry and long term care, shelter, restoration and long term rehabilitation of children availing of open shelter facility.

DISTRICT CHILD PROTECTION UNIT

ICPS envisages setting up of District Child Protection Unit (DCPU) in each district as a fundamental unit for the implementation of the scheme. The DCPU shall coordinate and implement all child rights and protection activities at district level. To date, four DCPU's have been set up by the SCPS having jurisdiction over 8 districts (as mentioned in the table below). The DCPU's have been attached with the existing Child Welfare Committees (CWCs).

The four DCPU's have been attached with the existing Child Welfare Committees (CWCs) with the objective of providing all the necessary support related to care, protection and rehabilitation of children. The ICPS Unit, Department of WCD proposes to set up six more DCPU's in the rest of the districts for which an advertisement shall be floated in the newspapers and the selection; recruitment shall be done as per procedure.

Main functions of DCPU are:

- 1. Identify families at risk and children in need of care and protection through effective networking and linkages with ICDS functionaries, Specialised Adoption Agencies (SAA), NGO's dealing with child protection issues and local bodies.
- 2. To identify unlicensed CCI's in the respective districts and facilitate the process of applying for license under the relevant sections of the JJ Act 2000.
- 3. Map all child related service providers and service at district for creating a resource directory
- 4. Ensure that for each child there is an individual care plan and that the plan is regularly reviewed. Monitor the implementation of the plan
- 5. Identify and support credible voluntary organizations to implement programme components of the ICPS
- 6. Support implementation of family based non- institutional services sponsorship, foster care, adoption and after care
- 7. Network and coordinate with voluntary and civil society organizations working in the field of child rights

TASKS UNDERTAKEN BY DCPU's

Handling cases under "Scheme for Financial Sustenance Education and Welfare for children of incarcerated parents 2014" as per directions received from the concerned Child Welfare Committees.

Handling and following up of POCSO cases and getting the victim compensation amount released as per order of the Hon. court by coordinating with the concerned departments like- divisional Commissioner, Revenue, DLSA and making home visits of the child victims to ensure their well being & rehabilitation. The Hon. Court is apprised by the DCPO of the efforts made as per the directions.

Constitution of Management Committees and Children's Committees in child care institutions in the respective districts and attending regular meetings to ensure proper care, management as per the provisions laid down in the JJ Act 2000. The main objective is to monitor the progress of every child housed in the institution and ensure that the necessary programmes and services for children are delivered effectively.

Regular monitoring of all child care institutions, open shelters, adoption agencies and shelter homes to assess and review the programmes and services delivered to children as per the ICPS guideline and provisions of JJ Act 2000. The DCPU's are also instructed to identify, visit and list out all unregistered and unlicensed CCI's in their respective districts and guide them for applying for license and bring such matters to the notice of the department.

Organising awareness and sensitization camps in communities, schools, hospitals, NGO's on prevention of illegal adoption and setting up of cradle points in hospitals, protection of children from sexual abuse, child rights, education and legislations for children.

Organising health / medical camps for children in Govt. run CCI's . Health camps such as- eye check up camp, dental camp s and general health check up camps are held in collaboration with Govt. hospitals wherein a team of doctors conduct the camp.

Providing counseling services to children in need of care and protection. Cases for counseling are referred through CWC's, SJPU's. Wherever required, home visits are also carried out by the DCPU staff followed by regular follow up. In addition, the Protection Officers and Legal cum Probation Officers regularly attend the JJB proceedings and also give the necessary support to CWC.

The DCPU's play an active role in the process of identification of all children at risk, trapped in difficult circumstances and in need of immediate care & protection in the respective districts. Children engaged in child labour, found on pavements / by the roadside in need of immediate medical care and assistance, children to be admitted to school are immediately reached out by the DCPU staff for timely care, protection and rehabilitation.

- v) Orientation / training programme for DCPU's and SAA's on "Introduction to the Revised Adoption Guidelines 2015" and hands on training on "CARINGS" in collaboration with CARA providing guidance for adoption process through DCPU's.
- **vi)** Meeting to be held with concerned stake holders to discuss "Quantification of the number of children residing in brothels at G.B. Road, their rescue and rehabilitation of children by putting them in a residential school
- vii) Training programme for DCPU's on "Track the Missing Child Web Portal" enabling them to provide all the necessary assistance to the child care institutions in their respective districts and facilitate the process of regular entries of children by CCIs on the portal.
- □ Constitution of District Child Protection Committees: As per the guidelines of ICPS, the District Child Protection Committees shall be constituted in the existing eight districts. The Department of WCD has already initiated the process of communicating with all the concerned departments with a request to nominate members from their respective departments as members in the DCPC to facilitate smooth functioning of the DCPUs at the district level as per the ICPS scheme (Under Process)

☐ Facilitate/ Setting up of six new DCPUs:

In addition to the existing four DCPU's, the SCPS shall set up six more **DCPU's** in 2015-16. The matter related to shortlisting of applications received in response to the advertisements floated in leading newspapers is under process which shall be followed by conducting interviews as per procedure (matter is under process).

☐ Proposals invited from NGO's for running Shelter Homes for children to be funded under ICPS scheme of , MWCD, GOI:

The SCPS, DWCD floated an EOI in the leading newspapers inviting applications from Delhi based NGOs for running Shelter Homes for children in need of care and protection for GIA under ICPS for 2015-16 under the following categories:


- a) Children in to substance abuse
- b) Children in begging
- c) Girl street children
- d) HIV affected children

As per procedure, the proposals shall be reviewed and scrutinized followed by an Evaluation through power point presentation to identify and shortlist the NGO's. The shortlisted NGO's / proposals shall further be forwarded to the M/O WCD, GOI for final decision with regard to release of GIA for 2015-16.

☐ Proposals invited by the State Adoption Resource Agency, DWCD, GNCTD through Expression of Interest from the NGO's/voluntary organisations for running a Specialised Adoption Agency in Delhi.

Through the advertisement floated, preference has been given to NGO's having good experience of working with children in need of care and protection or running children's home/ shelter homes for children.

Of the six proposals received, two NGO's have been shortlisted and briefed about the adoption guidelines and if interested, may apply for license under section 34 and 41 of IJ Act 2000.



STATE ADOPTION RESOURCE AGENCY (SARA)



"It's not enough to love the children, it's necessary that they are aware that they are loved. Through the beautiful gift of Adoption, let us fill their life with hope, warmth, love and comfort and make them realize that they are loved ".

The State Adoption Resource Agency (SARA) came in to existence in September 2011 in the premises of the Department of WCD, GNCTD under ICPS to coordinate, monitor and develop the adoption program in the State.

Functions of SARA:

- → Supporting Central Adoption Resource Authority (CARA) to promote in--country adoption, regulate inter-country adoption in the state of Delhi
- Monitoring of Specialised Adoption Agencies (SAAs)
- → Providing counselling, guidance and referral services to adoptive parents and facilitate inter-state adoption
- → Timely collection of monthly and quarterly reports from all SAAs on a regular basis and online submission to the Ministry of WCD

At present, 12 Specialized Adoption Agencies (SAA) are recognized under Section 34 and 41 of Juvenile Justice Act 2000. All the Specialized Adoption Agencies (SAA) have been directed to follow the Guideline, governing the Adoption of Children issued by Central Adoption Resource Authority, Ministry of Women & Child Development and Government of India. Regular monitoring of the Specialized Adoption Agencies is conducted by SARA to ensure that the adoption guidelines are adhered to by the Adoption agencies.

Main Programmes undertaken by State Adoption Resource Agency (SARA):

a) Regular monitoring of SAA's to ensure that adoption guidelines are being followed / adhered to by the agencies

- **b)** Receive and process the dossiers received from RIPA's for Inter-country adoption and act as a secretariat for the ARC (Adoption Recommendation Committee)
- c) Awareness programmes on prevention of "Private / Illegal Adoption through Hospitals / Nursing Homes" is held for doctors and nursing staff of Govt. run hospitals. These programmes are held in coordination with the CWC's, and DCPU's.
- **d)** Providing guidance and counselling to couples who are interested in adoption
- **e)** Facilitate the setting up of Specialized Adoption Agency and maintaining an updated and comprehensive list of such agencies
- **f)** Publication of notices and list of Adoption Agencies in the newspapers with the objective to create mass awareness and inform people of the registered / licensed adoption agencies in Delhi
- **g)** Two adoption agencies- Asharan and Welfare Home for Children have been recommended for GIA under ICPS

Action Plan of SARA:

- 1. To identify child care institutions which are not recognized as specialised adoption agencies, and link them to Specialised Adoption Agencies and to facilitate adoption of eligible children in such institutions. This objective shall be met through a coordinated effort of the CWC's and DCPU's.
- 2. SARA proposes to invite an "Expression of Interest" from NGO's to apply for license/ recognition for running a Specialised Adoption Agency in Delhi.
- 3. SARA proposes to organise frequent / regular awareness programmes in the Govt. and private hospitals for doctors and nurses on "Setting up of cradle in hospitals & Prevention of Illegal Adoption"
- 4. As part of the mass awareness programme, SARA proposes to publish the contact details of adoption agencies & DCPUs once in a year

MINUTES OF THE FOURTH GOVERNING BODY MEETING OF STATE CHILD PROTECTION SOCIETY, DELHI

The fourth Governing Body meeting of State Child Protection Society, Delhi was held on 11th March 2015 at 12.00 p.m. in Hall no. 3, 2nd level, Delhi Secretariat, I P Estate, New Delhi under the Chairpersonship of the Hon'ble Minister, WCD and SW, Mr. Sandeep Kumar.

Director, W&CD / Member Secretary of SCPS, welcomed the Hon'ble Minister, Women and Child Development (Chairperson of the Society), members / representatives from various departments present during the meeting. The meeting started with a brief introduction of the ICPS scheme and power point presentation of the status of ICPS Scheme in Delhi by the Director, Department of W&CD. The presentation threw light upon:

- Programmes initiated by the State Child Protection Society under the Scheme
- The service delivery structures under ICPS with the main objective of reaching out to every child in need of care & protection
- Functions and power of the Child Welfare Committees.
- Role and functions of the District Child Protection Units and the State Adoption Resource Agency

The Hon. Minister, during the presentation and discussion, sought information on the concept of the open shelter programme, the existing open shelters funded under the ICPS scheme, background information of the beneficiaries availing of the open shelter services, average stay of child in the open shelter and their rehabilitation.

 It was suggested that Salaam Baalak Trust, NGO may submit a detailed report on their open shelter programme funded under the ICPS scheme, GOI to the Ministers Office with child wise report of service given and rehabilitation of the child.

During the discussion, the Hon. Minister of WCD said that suggestions and inputs from various departments, stakeholders pertaining to well being, welfare and rehabilitation of children are welcome. Important and relevant Information can be shared through meetings and via email.

In this regard, Member, DCPCR shared information on SOP developed by the Railway Police for rescue and rehabilitation of children arriving at the stations in Delhi from various states.

 Member, DCPCR was requested to forward a copy of the SOP to the Ministers Office & concerned officials of the Department of WCD. The members present were also apprised of the decision of the Project Sanctioning Committee Meeting of ICPS held in September 2014 regarding discontinuation of financial support to two NGO run open shelters- Sahyog Charitable Trust and Prayas Yamuna Bazaar Open shelter w.e.f. November 2014 as their performance was not found to be up to the mark

Matter related to restoration of children to their families in their native village / place was also taken up during the meeting wherein the members felt that parents of children restored should be made to realize their responsibility towards their children as the State cannot take the responsibility of all the children.
