The State Child Protection Society, Delhi established for the purpose of implementing Integrated Child Protection Scheme in the State invites "Expression of Interest" for Need based/Innovative project for children under ICPS in Delhi for children in need of Care and Protection in accordance with the norms and guidelines prescribed under the Scheme for the NGO's / Voluntary organizations registered /licensed under relevant legislation for Grant in Aid for single year Grant - in - Aid for the financial year, 2017-18.

- Innovation in improving the situation of children in Need of Care & Protection
- Program that will serve as a model for other institutions
- Sustained financial and programmatic viability.
