As per the existing seniority Rules, Circulated by the DOPT vide OM Dated 03/07/1986, "The Seniority of persons considered Fit for promotion at the same time shall be the same as the relative seniority in the lower grade from which they are promoted". Hence the representations are considered and rejected.
