

Ltd was issued fire safety certificate by this department vide letter no. F.6/DFS/MS/2014/WZ/509 Dated 24/04/2014. The premises was re-inspected by the officer concerned of this department on 10/04/2017 in the presence of Mr. Kaul and found that the building have complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010, and premise is fit for class Group 'D' Assembly Buildings, Sub Div D-6 with effect from 27/04/2017 for a period of three years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rule, 2010.

1. Means of escape shall not be kept locked or bolted from outside and shall be easily open able by guests in an event of emergency.
2. All employees shall be acquainted with the use and maintenance of all the fire fighting installation/equipments.
