


The fire protection system such as fire extinguishers of different type and capacity, fire buckets filled with loose dry sand & water provided at suitable places in the retail outlet area were checked and found functional at the time of inspection. "No Smoking" sign boards were found displayed both in Hindi & English at conspicuous places. No loose electrical wiring was seen in the premises.

Keeping in view of the deemed compliance of the minimum standards on fire prevention and fire safety measures as required under the rules, the FSC issued vide letter No. F.6/DFS/MS/2014/SZ/717 dated 12.06.2014, renewal under rule 37 of the Delhi Fire Service rules, 2010 is recommended.
