OFFICE ORDER

On the recommendation of Screening Committee held on 31.08.2017 in the chamber of Chief Secretary/Chairperson for grant of 1st financial up-gradation under ACP Scheme to Sh. Suresh Singh, the than Station Officer, Delhi Fire Service in accordance with the instructions contained in Memorandum No. 35034/1/97-Estt. (D) Dated 09/08/99 of the Govt. of India, Ministry of Personal, Public Grievances & Pensions (Deptt. of Personal & Training) and endorsed by Finance (Budget) Department Govt. of NCT of Delhi vide No. F14920/99-Fin (B) dated 27.08.1999, the Hon'ble Lt. Governor, Delhi is pleased to grant 1st financial up gradation, from pay scale of Rs.6500-200-10500/- (Pre-Revised) to pay scale of Rs.8000-275-13500/- (Pre-Revised) on completions of **12 Years** of regular service as Station Officer, DFS, to Sh. Suresh Singh (D.O.B-15.10.57) w.e.f 13.11.2005.

This financial up gradation is purely personal to the incumbent and is restricted for financial and certain other benefits. The above official may exercise his option with regard to fixation of pay, if any as per FR-22(I) (a) (I) within One month of the issue of this order. The financial benefit allowed under the ACP Scheme shall be final and no pay fixation benefit shall be accrue at the time of regular promotion. The Head of Office before implementing the orders for grant of ACP will check the service particulars of Sh. Suresh Singh, D.O (CDC) and if there is any discrepancy, the same may be brought to the notice of undersigned immediately.

However, the grant of higher pay scale is subject to the undertaking that in the event of overpayment, which may be detected at a later stage the same will be recovered from his pay with prior notice.

The Head of Office, Laxmi Nagar Division shall ensure that the officer have completed 12 years of regular service and no Major/Minor penalty is in operation on the date of grant of ACP.
