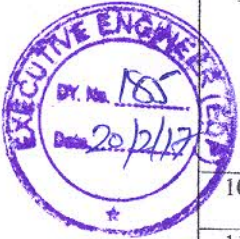

The up-gradation is further subject to the following condition:-

1. Pay and Allowance of the incumbent will be fixed under the provisions of FR -22 (I) a (1) subject to the terms and conditions contained in Dir (A&P)'s circular No. DJB/AC(W)/ACP/99/7377 dated 30.11.99 & clarification dated 05.11.2000 & O.M. No. 350034/1/97/Estt.(D) dated: 09/08/1999 & O.M. NO. 35034/3/2008 – Esstt. (D) Dated: 19/5/2009 of DOPT respectively. The officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade. If any, under FR – 22 (I) a (1) within one month of the issue of the order, granting the financials up-gradation under the ACP/ MACP Scheme.
2. Before fixation of pay under ACP/MACP Scheme, DDO concerned shall ensure/verify that concerned employee either has completed 12,24 & 10/26/30 years of qualifying service as on 09/08/99 & 01/09/08 respectively for granting benefit of 1st/2nd/3rd financial up-gradation under ACP/ MACP without any break or unqualified service.
3. The DDO concerned shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial upgradation / promotion. Further explanation will be called for none submission of cases for granting financial up-gradation under ACP/MACP by the DDO in time.
4. The financial up-gradation is merely placement in immediate next higher grade pay and this does not amount to functional regular promotion or seniority benefit etc.
5. DJB employee (E&M & Dist. side), if any, in the list shall be identified by the DDOs and processed separately as per different rules / orders in such cases.
6. The financial upgradation is subject to the verification of Audit.

Note: - The DDOs concerned are hereby requested to review the 2nd/3rd MACP cases of these DDA transferred staff according to revised 1st / 2nd Financial Up-gradation under ACP Scheme without any delay. Moreover if MACP cases are still pending with DDO, send the same immediately to this office. So that MACP could be granted to them.
