- The pay and allowance of the incumbents will be fixed under the provision of FR-22 (I) a (1) subject to the terms and condition contained in the DOP&T order No. 35034/3/2008- East (D) dated 19.09.2009, used under the signature of the Dy. Sect. to the Govt. of the India and including subject to implementation of penalty order etc while implementing the above MACP/ACP scheme is operative w.e.f. 01.09.2008.



3. Dy.Dir (F&A) – I letter DJB/ACA/2010/38810 dated, 29.04.2010 and further corrigendum No. DJB/ACA/ (F&G)/2009/39737 dated 30.04.2010. The officials concerned may be allowed to exercise their option. for fixation of pay after accrual of increment in the lower grade if any, under FR-22 (I) a (1) within month of the issues of the order, granting the financial up-gradation under the MACP/ACP Scheme.
4. At the time of fixation of the pay of the above employees, the DDO will ensure the official have completed at least 10/20/30 years/12&24 years qualifying service, as the case may be, on the above dates without any break or unqualified service and he should be clear from vigilance angle.
5. The financial up gradation is merely placement in next higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc. in the grade.
6. All the conditions /stipulations contained in DOP&T OM dated 19.05.2009 be strictly followed while implementing the MACP/ACP Scheme in respect of concerned officials.
