Consequent upon the recommendation of Departmental Screening Committee and further approval by CEO, DJB dated 28.02.2017, following SEs(E&M) are hereby promoted to the post of Chief Engineer(E&M) on ad-hoc basis in the Pay Band-4 of Rs.37400-67000 with Grade Pay of Rs.10,000/-(pre-revised under 6th CPC) plus other usual allowances as admissible under the rules, with immediate effect, initially for a period of six months or till such time this post is filled in on regular basis through UPSC or till retirement on attaining the age of superannuation or till further orders, whichever is earlier.

It is, further, subject to following term & conditions :

1. The ad-hoc promotion will not confer any right on the officers to claim for regular promotion to the post or any other service benefit.
2. That the service rendered on ad-hoc basis in the grade concerned would not count for purpose of seniority in that grade and for eligibility for promotion to the next higher grade.
3. The competent authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
5. The ad-hoc promotion is also subject to final outcome of various court cases pending before Hon'ble Courts including A. K. Awasthi Vs.DJB.
