Consequent upon recommendation of Delhi Subordinate Services Selection Board (D.S.S.S.B.) for appointment to the post of Junior Engineer(E&M) and with the approval of the Competent Authority of DJB, Shri Kuldeep Singh S/o Shri Balbir Singh, Employee No. 20007616, Foreman C/o EE(E&M)-II, DJB r/o E-1, DJB Staff Quarters, Water Works, Wazirabad, Delhi – 54 was offered temporary appointment to the post of JE(E&M) in Delhi Jal Board in the Pay Band-II of Rs. 9300-34800 + Grade Pay Rs. 4200/- plus usual allowances as admissible under the rules vide Memorandum bearing No.F.No.223/DJB/AC(T)/JE(E&M)/Apptt./2016/661 - 665 dated 09.05.2017 along with the terms and conditions for appointment to the post of J.E.(E&M) in Delhi Jal Board.


Further, educational/technical qualification has been verified from the concerned Authorities/University/Board/Institution. The EE(E&M)-II, DJB has also confirmed that individual has already found medical fit and the verification of character and past antecedents has already been completed at the time of initial appointment of the individual in the erstwhile DWS & SDU (Now Delhi Jal Board). The clearance from the vigilance department has also been obtained.

Now, consequent upon acceptance of above referred terms and conditions by the individual vide his acceptance letter dated 11.05.2017 for appointment to the post of Junior Engineer (E&M) in Delhi Jal Board and with the approval of the competent authority, Shri Kuldeep Singh is hereby appointed temporarily to the post of Junior Engineer (E&M) in Delhi Jal Board with immediate effect. He will remain on probation for a period of two years.

The above appointment is subject to the outcome of (i) C.P. (C) 1068/ 2015 in the matter of Shri Hemant Kumar Sharma & Others V/s DJB, GNCTD & Others and (ii) O.A.No. 3390/2015 in the matter of Sh. Lokit Parkash & others V/s Delhi Jal Board & others pending before the Hon'ble Tribunal.
