

1. The MACP scheme is implemented vide Govt. of India Dept. of per & Try. O.M No. 35034/3/2008- East (D) 19.05.2009 and the pay and the dated of increment would be fixed in accordance No. 2 of Department of expenditure's No. O.M No. 01.01.2008-IC dated 13.09.2008
2. The pay and allowance of the incumbents will be fixed under the provision of FR-22 (I) a (1), subject to the terms and condition contained in the DOP&T order No. 35034/3/2008- Estt (D) dated 19.09.2009, used under the signature of the Dy. Sect. to the Govt. of the India and including subject to implementation of penalty order etc while implementing the above MACP/ACP scheme is operative w.e.f. 01.09.2008.
3. In pursuance of (Dy.Dir (F&A) – I letter DJB/ACA/2010/38810 dated 29.04.2010 and further corrigendum No. DJB/ACA/ (F&G)/2009/39737 dated 30.04.2010), the officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade if any, under FR-22 (I) a (1) within a month of the issue of the order, granting the financial up-gradation under the MACP/ACP Scheme.
4. At the time of fixation of the pay of the above employees, the DDO will ensure that the officials have completed at least 10/20/30 years/12&24 years qualifying service, as the case may be, on the above dates, without any break or unqualified service and they should be clear from vigilance angle.
