- 2. The pay and allowance of the incumbents will be fixed under the provision of FR-22 (I) a (1), subject to the terns and condition contained in the DOP&T order No. 35034/3/2008-Estt (D) dated 19.09.2009, used under the signature of the Dy. Sect. to the Govt. of the India and including subject to implementation of penalty order etc while implementing the above MACP/ACP scheme is operative w.e.f. 01.09.2008.
