

It is, further, subject to usual terms and conditions of ad-hoc promotion as mentioned hereunder:

1. The ad-hoc promotion will not confer any right on the officers to claim for regular promotion to the post or any other service benefit including seniority in that grade and for eligibility for promotion to the next higher grade.
2. The period of service rendered on ad-hoc basis will not count as officiating in the higher grade for any purpose.
3. The competent authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving any prior notice.
4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
5. The ad-hoc promotion is also subject to the outcome of Court cases pending before the Hon'ble Supreme Court/High Court/CAT, if any.
