- B. The pay and allowance of the incumbents will be fixed under the provisions of FR-22(I) a (I) subject to the terms and conditions contained in the DOP&T order No. 35034/3/2008-Estt. (D) dated 19.05.2009 issued under the signature of the Dy. Secy. to the Govt. of India and including subject to implementation of penalty order etc. while implementing the above MACP/ACP scheme by the DDO concerned. The scheme is operative w.e.f. 01.09.2008 in case of MACP & 09.08.99 in case of ACP.
- C. Dy. Director (F&A)-I letter DJB/ACA/(F&G)/2010/38810 dated 29.04.2010 and further corrigendum No. DJB/ACA/F&G/2009/39737 dated 30.04.2010. The official concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade,
- D. if any, under FR-22(I) a(I) within one month of the issue of the order, granting the financial up-gradation under the MACP/ACP Scheme.
- E. At the time of fixation of the pay of the above employee, the DDO will again confirm that the officials have completed at least 10/20/30/ 12 & 24 years of qualifying service, as the case may be, on the above dated (vide Volume-4) without any break or unqualified service and he should be clear from vigilance angle.
- F. The financial up-gradation is merely placement in next higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc. in the grade.
- G. The DDO will verify that the employees recommended for financial upgradation were not under currency period of penalty, on the date from which financial up-gradation has been recommended/allowed to him.
- H. All the conditions/stipulations contained in DOP&T OM dated 19.05.2009 be strictly followed while implementing the MACP/ACP Scheme in respect of concerned officials.
- I. The grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
