The Member (Admn.), Delhi Jal Board vide his orders dated 18.10.2017 has been pleased to accord approval for the Payment of Non-Productivity linked Bonus (Ad-hoc Bonus) for the financial year 2016-2017 to all workers engaged on contractual basis directly by Delhi Jal Board subject to the following terms & Conditions.

1. The contractual workers who have worked in offices following a six day week for at last 240 days for each year for 3 years or more (206 days in each year for 3 years or more in case of offices observing 5 days week) will be eligible for this Non-PLB (Ad-hoc Bonus) payment. The amount of Non-PLB (ad-hoc bonus) payable will be ₹ 1200 x 30/30.4 i.e. ₹ 1184.21 (round off to ₹ 1184/-) in cases where the actual emoluments fall below ₹ 1200/- P.M. the amount will be calculated on actual monthly emoluments.
2. All payments under these orders will be rounded off to the nearest rupee.
3. The payment under these orders will be chargeable to the Sub-head "Salaries" in the relevant demand for grant of the organization concerned.
4. The expenditure incurred on account of Non-PLB (Ad-hoc Bonus) is to meet from within the sanctioned budget provision of concerned Divisions / Offices for the current year.

This issue with the concurrence of finance & accounts Deptt. of Delhi Jal Board.

All the concerned DDO's are, therefore, requested to kindly ensure the payment of Ad-hoc Bonus for the financial year 2016-2017 accordingly to the contractual worker working under them immediately.


