Sub.: Review of financial upgradation granted to one Sh. Lokesh Kumar, Asst. Chemist under MACP/ACP Scheme reg.

Whereas a case for review of financial upgradation granted to one Sh. Lokesh Kumar, Asst. Chemist under MACP/ACP scheme was forwarded by his DDO/ CWA (W&S) I and the same was placed before the Departmental Screening Committee (DSC) comprising of following members:-

Whereas it was noticed by the DSC that 1st MACP to Sh. Lokesh Kumar was given vide AC(B) office order no.27 dated 11-05-2011 considering his first appointment w.e.f. 05-05-1997 as Lab. Technician. Subsequently, Sh. Lokesh Kumar was appointed to the post of Asstt. Chemist notionally w.e.f. 01-05-2005 under direct recruitment quota vide AC(B) office order no.07 dated 17-01-2014 in compliance to the orders of Hon'ble CAT.

Whereas the DSC further considered Sr.ACGDA (AN)'s Circular dated 10.12.2012 vide which DoP&T has clarified that such appointment shall be treated as direct recruitment and past service/promotion will not be counted for the benefits under ACP/MACP Schemes. As such regular service for grant of benefits under the scheme will be counted from the grade in which an employee was appointed as a direct recruit for MACP/ACP purpose.

Whereas having regard to the ACP/MACP guidelines and further clarification in this context, the Committee recommended following MACP benefit to Sh. Lokesh Kumar, Asst. Chemist in supersession/withdrawal to AC(B)'S office order no.27 dated 11-05-2011 and AC(B)'s office order no.113 dated 17-08-2016:-

Whereas the above recommendations of the DSC were accepted and approved by the Competent Authority.

Now, therefore, Sh. Lokesh Kumar, Assistant Chemist, S/o Sh. Roop chand is hereby granted Ist financial upgradation under MACP Scheme in the Grade Pay of Rs.4800/- in Pay Band PB-2 Rs.9300-34800/- w.e.f. 01-05-2015 which is in supersession/withdrawal to financial upgradation earlier granted to him vide AC(B)'S office order no.27 dated 11-05-2011 and AC(B)'s office order no.113 dated 17-08-2016 subject to following usual terms and conditions:-

- Pay & Allowance of the incumbents will be fixed under the provisions of FR-22(I) a (1) subject to the terms & conditions contained in DOPT O.M. No. 35034/3/2008- Estt. (D) dated 19-05-2009 respectively. The officials concerned may be allowed to exercise their options, if any, under FR-22 (I) a (1) within one month of the issue of the order, granting the financial up-gradation under the MACP scheme.
- At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or he has spent 10 years continuously in the same grade pay for grant of benefit of 1st/ 2nd/ 3rd/ financial up-gradation under MACP Scheme without any break or unqualified service.
- The financial up-gradation is merely placement in higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc
- The financial up-gradation is subject to verification of Audit.
- The DDO will verify that the employees recommended for financial up-gradation was not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- The DDO concern shall also ensure/verify that the employee recommended by DSC has not been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
