The pay and allowances of the incumbents will be fixed under the provisions of FR-22 (I) a (1) subject to the terms and conditions contained in the DOP&T order No. 35034/3/2008-Estt.(D) dated 19.05.2009, issued under the signature of the Dy. Secy. to the Govt of India and including subject to implementation of penalty orders etc while implementing the above MACP/ACP scheme by the DDO concerned. The scheme is operative w.e.f. 01.09.2008.

Dy.Dir.(F&A)-I letter DJB/ACA(F&G)/ACP/2010/38810 dated 29.4.2010 and further corrigendum No. DJB/ACA/(F&G)/2009/39737 dated 30.4.2010. The officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade if any, under FR-22 (I) a (1) within one month of the issues of the order, granting the financial up-gradation under the MACP/ACP Scheme.






