Consequent upon the recommendations of Departmental Screening Committee and further approval of CEO, DJB dated 22.12.2017, **S/Sh. S. K. Bhardwaj and Shalabh Kumar, Superintending Engineers (Civil)** are hereby promoted to the post of Chief Engineer (Civil) with immediate effect on ad-hoc basis in the Pay Band-4 of Rs. 37,400-67,000 with grade pay of Rs. 10,000/- (pre-revised) plus usual allowances as admissible under the rules initially for a period of one year or till such time the post is filled in on regular basis through UPSC or till further orders, whichever is earlier subject to the following terms & conditions:-

1. The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or any other service benefit.
2. The period of service rendered on ad-hoc will not count on officiation in the higher grade for any purpose.
3. The Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notice.
4. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
5. The ad-hoc promotion is also subject to various court cases pending in any Court.

Further, aforesaid officers are hereby transferred and posted as under:-

1.	Sh. S.K.Bhardwaj, SE (Dr.) Project North & North West	CE(East) relieving Sh. Ramesh Thakur, CE(West) from the additional charge of CE(East).
2.	Sh. Shalabh Kumar, SE(South)	CE(South) relieving Sh. R. S. Negi, Member (Drainage) from the additional charge of CE(South).

The charges of SE (Dr.) Project North & North West and SE(South) will be looked after by their Link Officers till further orders.
