On recommendation of the Screening Committee constituted for grant of Financial up-gradation under Modified Assured Career Progression Scheme to Ex-Cadre officials on the strength of Revenue Department and in accordance with the instruction contained in OM No. 35034/3/2008-Estt.(D) dated 19/05/09 of the Govt. of India, Ministry of Personnel, Public Grievance & Pension (Dept. of Personnel & Training) endorsed by the Finance Department, GNCTD vide No.F.11(4)/2006/Fin.B/Pt-II/DSFB/1192-1197 dated 27-05-09 and in pursuance to the Revenue Department, GNCTD order No.F.23(171)/MACP/2014/458 dated 05/02/16 **Sh.
