Directorate of Gurdwara Elections vide their letter dated 13.02.2017 has intimated that 73 officials (11 Grade-II (DASS), 42 Grade-III (DASS), 20 Grade-IV (DASS)) deployed from your department for the conduct of Gurdwara Elections vide Services Department's letter dated 27.01.2017, have not reported for election duties. Further, it has also intimated that the first training for the officials deputed for Gurdwara Elections is scheduled to be held on 16.02.2017.

In this regard, it is informed that the whole process of Gurdwara Elections is being monitored by the Hon'ble High Court of Delhi and various directions have been issued for time bound completion of the election process by Hon'ble High Court In writ petition No.4155/2016 and contempt petition No.960/2016. The Gurdwara Elections are already notified and is scheduled for 26.02.2017. As such nonreporting by the officials deployed for polling duties will hamper the whole process.

Therefore, I am directed to request you to direct the abovementioned officials to report to Directorate of Gurdwara Elections latest by 15.02.2017 without fall. A compliance report in this regard may be forwarded to this department by return FAX.
