ORDER

It has been decided to celebrate the 64<sup>th</sup> Independence Day on Sunday, August 15, 2010 at the Head Quarter of Revenue Department as well as in the office of Deputy Commissioners. In this connection, the following instructions are issued for strict compliance:

1. Independence Day shall be celebrated in all the district offices by flag hoisting by the respective Dy. Commissioners. Similar action will be taken by SDM's where SDM offices is located away from the D.C. office of the district.
2. Every DC office and every SDM office which is located away from the DC office should have a Flag Post/Pole as prescribed and shall celebrate Republic Day and Independence Day every year by flag hoisting. Sufficient funds for this purpose are available with the Deputy Commissioners under Major Head 2053(Non Plan), Minor Head H.3(1)(1)(4) OE (NP) & Major Head 2053 (Plan) Minor head H.3(1)(1) (7) Minor works (Plan) for immediate erection of flag posts/ poles.
3. No DC/ADM/SDM/Tehsildar shall be granted station leave.
4. A copy of the Flag code of India 2002 circulated by the Ministry of Defence, Govt. of India is sent/enclosed for guidance.

An action taken report on the Celebration of Independence Day 2010 may be sent to this office by August 18, 2010.

Henceforth Republic Day and Independence Day shall be celebrated in the Revenue Department as directed above.
