

2. If the official nominee is not in a position to attend any meeting, he / she shall seek approval from Minister-in-Charge for the same;
3. After returning from that meeting, the official nominee shall submit a written report to Minister-in-Charge of the proceedings within two days.

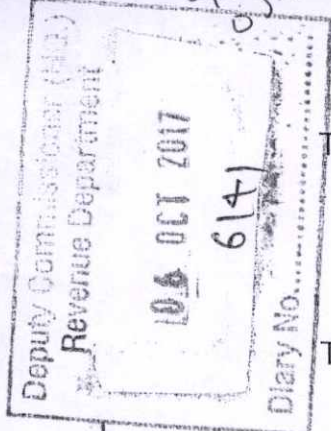
