In my previous letter, inter-alia, I had also requested you to designate a Nodal Officer in the Office of your representative in Delhi to pre-authenticate the documents (personal and educational) originating from your State / UT and share his / her contact details with this Ministry. In response, we have received retary (Rev) information from the States / UTs of Bihar, Jharkhand, Madhya Pradesh, Nagaland, Odisha, Dadra & Nagar Havelikand Daman & Diu. Prompt response from these States / UTs is highly appreciated. As you are aware, designating an officer in Delhi considerably reduces huge trouble the applicant from the respective State / UT has to undergo while getting documents attested for business, education and travel in overseas countries. I would encourage other States / UTs too, to kindly expedite the process of designating Nodal Officers in the Office of their representatives in Delhi to authenticate / attest the documents. Cooperation from your Office in this regard shall be very helpful in ensuring timely and hassle free service to the applicant. Further, it gives me immense pleasure to inform you that the implementation of e-Sanad is making good progress and recently the External Affairs Minister launched the integration of e-Sanad with Maharashtra State Education Board and Confederation of Indian Industries. I would further like to inform you that discussions between the Technical Team of NIC and the States of Bihar, Delhi, Gujarat, Himachal Pradesh, Kerala, Manipur and Punjab is in its advanced stages. This Ministry is also in touch with many other organizations including the Ministry of HRD's National Academic Depository (NAD) and many Chambers of Commerce for its integration with e-Sanad.

- 5. Once the digital depositories of all the State / UT Governments are integrated with e-Sanad, the need for physical attestation shall be obviated. This shall be a welcome relief for the applicants who otherwise have to go through the time consuming process of getting attestation from the Document Issuing Authorities and then the Ministry of External Affairs. This will also mostly eliminate the instances of attestation of forged documents.
- 6. As the integration of e-Sanad with all the States & UTs / organizations will take time, designating Nodal Authorities at Delhi is of utmost importance to avoid any inconvenience to the applicants, who then would be able to complete the entire process of attestation at Delhi itself. I would like to further reiterate our commitment to extend full support of this Ministry as well as our NIC Technical Team in collaborating with your State / UT to achieve our aim of a public-friendly mechanism of attestation / Apostille.

A meeting was held under the Chairmanship of Chief Secretary, Delhi on 22.08.2017 at 05.00 pm regarding attestation of documents of Indian Nationals seeking job and education abroad. List of participants is at Annexure- I.

Sh. Upender Singh Rawat, Joint Secretary, Ministry of External Affairs, Govt. of India explained the key features of the portal named eSanad to be implemented for attestation of documents of Indian Nationals seeking job and education abroad. He also explained the procedure of online attestation through integration of databasis of various departments with the eSanad portal. He further explained that the Ministry wants to integrate eSanad with online documents depository of Delhi for verification of education and personal documents. This would require eSanad to be able to get relevant digitally signed document from Delhi's online depository.

The following decisions were taken during the meeting:

- 1. MEA will make a list of all documents which are usually apostelled
- 2. Department of Education, GNCTD will prepare a list of all educational/professional Institutional including universities, college, institute of skill training, central govt. universities, deemed universities etc. and ascertain the status of digitization of certificates, marksheets etc by those institutes
- 3. (i) Revenue Department will make a list of documents not available in digitally signed format, but can be made into digitally signed copies when an applicant applies for the same.
 - (ii) To make a list of all documents available in digital depositories.
- 4. All the Municipal bodies will take steps to make birth certificates, death certificates etc available in digital format.
- 5. Thereafter, Revenue Department and MEA will draft a plan for step wise integration of all documents available online with e-Sanad portal.

The meeting ended with thanks to the Chair.
