ORDER

This office had promoted 357 Group-D employees of various Departments of GNCT of Delhi, to the post of Laboratory Assistant in Directorate of Education, GNCT of Delhi, vide order No. DE.4(8)/(23)/E-IV/Lab.Asstt./2015/11590-11600 dated 08.09.2016. Later on for verification of their documents, a circular was issued vide even No. dated 20.09.2016 and subsequently, 2 reminders were issued vide even No. dated 05.10.2016 and 2.11.2016 respectively. Thereafter memorandum was issued vide even number dated 17.01.2017 to the concerned official's residential address and to their parent department giving final opportunity to join & accept promotion by 31.01.2017.

However, the following 27 officials have not joined the promotional post or refused to join or already promoted to Group-C posts or found ineligible.
