This appointment is temporary and on provisional basis for two years and further subject to: I) Verification of character and antecedents by the DDE concerned. In case character and antecedents of the candidate is found not verified or any false information is given by candidate in his/her self declaration, the appointment shall be cancelled forthwith and other criminal/legal action will also be taken, as a consequence thereof. II) Verification of documents/certificates of qualification including caste certificates and certificates for persons with disability by the concerned DDE from concerned Institute/Universities/Authorities on joining the respective school. However, the HOSs should ensure that the candidate mentioned at Serial No.2 is not to be allowed to join their respective posts, unless he/she provides a self attested copy of his/her "Technical Resignation" having being accepted by the competent authority from which, the candidate is coming to the Directorate of Education G.N.C.T.D. The appointment is subject to the mandatory condition that the candidate will acquire B.Ed/B.T. qualification within a period not exceeding three years from the date of joining service. This issues with the prior approval of competent authority.
