**ORDER**

**Whereas**, vide order dated 05/08/2013 department issued directions to the School Management/HoS of all Recognized Unaided Private Schools of Delhi to display the requisite information (in English as well as Hindi language), as ordered by Hon'ble CIC vide order dated 14/12/2010, on the notice board of the school which is easily visible from outside the school and to update the information on the board once every week. The said directions were reiterated afterwards also.

**And whereas**, schools were also directed to update the said information online on the modules designed for the same and the information updated by the respective schools was accessible to the general public through the link available on department website [www.edudel.nic.in](http://www.edudel.nic.in).

**And whereas**, during the proceedings held in WPC No. 4034/2017 & CM No. 17753/2017 titled "*Justice for all V/s Govt. of NCT of Delhi & Ors*", the issue regarding the compliance of order dated 05/08/2013 was raised before the Hon'ble High Court of Delhi.

**And whereas**, the Hon'ble High Court of Delhi vide order dated 07/07/2017 in the above captioned matter has issued directions that schools shall update all information on board once in every week as directed by Directorate of Education and Directorate of Education shall ensure the compliance of the above. The court further directed that the said information shall also be displayed on the website of the Directorate of Education as well to ensure its accessibility in one place to the public at large (copy enclosed).

**Now therefore**, the Managers/Principals of all the Private Unaided Recognized Schools of Delhi are hereby once again directed to update the requisite information online on the modules designed for the same on the department website at regular interval (once every week) and shall display/update weekly the following information (in both Hindi & English) on the board simultaneously which is easily visible from outside the school, as ordered by Hon'ble CIC vide order dated 14/12/2010 & reiterated by Hon'ble High Court vide above said order dated 07/07/2017:-

- The total no. of seats in all classes in a school.
- The total vacancies in all classes.
- The total no. of seats under EWS quota.
- Seats still available under EWS quota.
- Total applications received under EWS quota.




- Information about when the EWS quota applications will be received and date by which the admissions will be given.

The modules for updating the information online can be accessed through the following link (**login -> School Plant -> School Information -> Details of Admissions/Vacancy for session 2016-17 and 2017-18**) available on departmental website [www.edudel.nic.in](http://www.edudel.nic.in).

Further, the information filled/updated by the respective schools is easily accessible to the General Public through the link "**Details of Admissions/Vacancy for session 2016-17 & 2017-18 regarding Private Unaided Recognized Schools of Delhi**" available on the Home Page of department website [www.edudel.nic.in](http://www.edudel.nic.in) under the "Scroll Down" Menu.

Non compliance of the order shall be viewed seriously and action as per the relevant provisions of DSEAR, 1973 and RTE Act, 2009 will be initiated against the defaulting school management. Further, non compliance may also tantamount to the contempt of the directions of Hon'ble Court.



1. Our attention is drawn to the order dated 6<sup>th</sup> January, 2011 which was passed in WP(C)No.21/2011 *Delhi State Public School Management Association vs. Directorate of Education & Anr.* wherein the requirement in para 3 of the order dated 5<sup>th</sup> August,

2013 issued by the Directorate of Education, Government of NCT of Delhi stands partially stayed. We record herein the operative part of the order dated 6<sup>th</sup> January, 2011:

"5. ...It is made clear that the petitioner will continue to display information concerning the total number of seats in all classes in the member schools, the total vacancies in all classes, the total number of seats under economically weaker sections ('EWS') quota, the seats still available under EWS quota, the total applications received under the EWS quota and information on when the EWS quota applications are to be received and date by which the admissions will be displayed on the website of the DOE."

We are informed that this writ petition is pending even on date.

2. In view thereof, it is directed that all unaided recognized private schools management shall display the following information on board, as directed by the order dated 5<sup>th</sup> August, 2013 of the Directorate of Education :

- (i) The total no. of seats available in all classes in a school.
- (ii) The total vacancies in all classes.
- (iii) The total no. of seats under EWS quota.
- (iv) Seats still available under EWS quota.
- (v) Total applications received under EWS quota.
- (vi) Information about when the EWS quota applications will be invited and data by which the admissions will be given.

3. Schools shall update all information on board once in every week as directed by the Directorate of Education. The Directorate of Education shall ensure the compliance of the above.
4. The said information shall also be displayed on the website of the Directorate of Education as well to ensure its accessibility in one place to the public at large.
5. The compliance report shall be filed before us within one week from today.
