REMINDER – II MOST URGENT MATTER

ORDER

Subject: - Compliance of directions issued to all Private Unaided Recognized Schools of Delhi regarding display of information in respect of seats/vacancies under EWS quota.

Whereas, vide order dated 05/08/2013 department issued directions to the School Management/HoS of all Recognized Unaided Private Schools of Delhi to display the following requisite information (in English as well as in Hindi language), as ordered by Hon'ble CIC vide order dated 14/12/2010, on the notice board of the school which is easily visible from outside the school and to update the information on the board once every week.

- The total no. of seats in all classes in a school.
- The total vacancies in all classes.
- The total no. of seats under EWS guota.
- Seats still available under EWS guota.
- Total applications received under EWS quota.
- Information about when the EWS quota applications will be received and date by which the admissions will be given.

And whereas, schools were also directed to update the said information online on the modules designed for the same and the information updated by the respective schools was accessible to the general public through the link available on department website www.edudel.nic.in.

And whereas, the above said directions were reiterated afterwards also through various circulars/orders and recently, vide order dated 10/07/2017 which was issued in compliance of Hon'ble High Court of Delhi order dated 10/07/2017 passed in WPC No. 4034/2017 & CM No. 17753/2017 titled "Justice for all V/s Govt. of NCT of Delhi & Ors".

And whereas, the Hon'ble High Court of Delhi vide order dated 07/07/2017 in the above captioned matter had issued directions that schools shall update all information on board once in every week as directed by Directorate of Education and Directorate of Education shall ensure the compliance of the above. The court further directed that the said information shall also be displayed on the website of the Directorate of Education as well to ensure its accessibility in one place to the public at large.

And whereas, vide order dated 24/07/2017, the Manager/HoS of all Private Unaided Recognized Schools of Delhi were again directed to comply with the order of the department and Hon'ble Court in letter and spirit and also all Regional Directors, Directorate of Education, GNCTD were directed to ensure the compliance by all the Private Unaided Recognized Schools of Delhi falling under their jurisdiction.

And whereas, despite of issuing repeated circulars/orders/reminders, most of the Private Unaided Recognized Schools are not displaying/updating the above said requisite information neither on the notice board which is easily visible from outside the school nor online on the module designed for the same on the department website www.edudel.nic.in at regular intervals. Moreover, as per the photographs of the notice board submitted by the district DDEs, it reveals that many schools have displayed the information, only once, on a flimsy banner, rather than displaying the same on the notice board and updating the same at regular intervals. The competent Authority has taken a very serious view in this matter.

Now therefore, the Manager/Principal of all the Private Unaided Recognized Schools of Delhi are hereby once again directed to update the requisite information online on the modules designed for the same on the department website at regular interval (once every week) and shall also display/update weekly the requisite information (in both Hindi & English) on the board simultaneously which is easily visible from outside the school.

The modules for updating the information online can be accessed through the following link (*login* -> *School Plant* -> *School Information* -> *Details of Admissions/Vacancy for session 2016-17 and 2017-18)* available on departmental website www.edudel.nic.in.

Non compliance of the order shall be viewed seriously and action as per the relevant provisions of DSEAR, 1973 and RTE Act, 2009 will be initiated against the defaulting school management. Also, non compliance may tantamount to the contempt of the directions of Hon'ble Court.

Further, all Regional Director of Education and Deputy Director of Education (Concerned District) are once again directed to ensure the compliance of the above said directions by all Private Unaided Recognized Schools of Delhi falling in their jurisdiction and submits a certificate along with documentary proof that all the Private Unaided Recognized Schools of their jurisdiction have fully complied with the above said direction for perusal of the Competent Authority.
