**Sub: Extension of time line for implementation of this Directorate's Order dated 17/10/2017 in respect of 7<sup>th</sup> Central Pay Commissions Recommendations:**

In Pursuant to the order dated 14/11/2017 of Hon'ble High Court in CM No. 40939/2017 in WPC 10023/2017, titled as Association of Public Schools Vs Directorate of Education and in continuation of this Directorate's order no. 20164-169 dated 03.11.2017, the timeline as prescribed in Clause 3(II) (f) for the private unaided recognized schools running on the land allotted by DDA/Other Govt. Land Agencies is hereby extended for strict compliance of all concerned:-

The requirement of filing the statement of fee under section 17(3) of DSEAR, 1973 as prescribed in Sl.No.3 of clause 3(II) (f) of the order dated 17/10/2017 is omitted in view of the subsequent order dated 03/11/2017 mandating all the Private Unaided Recognized Schools concerned to file online proposal for any increase in fee.

The extension of time line shall only be applicable to the private unaided recognized schools running on the land allotted by DDA/Other Govt. Land Agencies having condition to seek prior sanction of Director (Education) before any fee hike.

The online module on this Directorate's website seeking the proposal of increase in fee by the schools shall remain open till 14.12.2017, midnight.


