ORDER

In supersession of all previous orders and in exercise of powers conferred upon Deputy Commissioner(Excise) under Section 8(2) of the Delhi Excise Act, 2009, the following powers of Deputy Commissioner(Excise) is hereby delegated to the concerned Assistant Commissioner(Excise), with immediate effect.

1. Renewal of Licenses in Form L-10.
2. Renewal of Licenses in Form L-12, L-12F, L-23, L-23 F and L-30 as provided under Rule 32 of the Delhi Excise Rules, 2010.
3. Grant/Cancellation of Permits P-9 and P-10A and all Passes as provided under Rule 17, Rule 19 and Rule 33 of the Delhi Excise Rules, 2010.
4. Revalidation/Extension of all Import Permits/Transports as provided under Rule 18 of the Delhi Excise Rules, 2010.
5. Renewal of Licenses in Form L-6, L-6FG, L-6FE, L-7, L-7FG and L-7FE.
6. Renewal of Licenses in Form L-8, L-9, L-9A and L-14.
7. Revalidation/Extension of all Import & Transport Permits of Country Liquor, as provided under Rule 18 of the Delhi Excise Rules, 2010.
8. Approval of P-13, approval of transfer of Liquor from L-15 store to L-16 store or vice-versa within same unit and signing of Transport permit for such transfer.
9. Approval for transfer of Liquor from one hotel to other hotel of same company/group with due justification of transfer and signing of Transport Permit for such transfer.
10. Renewal of Licenses in forms of L-15, L-15-F, L-16, L-16/16-F, L-17, L-17/L-17-F, L-18, L-18/18-F, L-19, L-19/L-19-F, L-28/L-28F, L-29, L-29/L-29F, as provided under Rule 32 of Delhi Excise Rules, 2010.
11. Enhancement/Reduction of seat covers and number of Rooms in Licensed premises of Hotel/Club/Restaurants as the case may be.
12. Confiscation of seized Liquor(where vehicle is not involved) under Section 59(2) and disposal thereof under Section 59(4) of Delhi Excise Act, 2009.
