ORDER

Hon'ble Lt. Governor of Delhi is pleased to order that Sh. O.P. Srivastava, Superintending Engineer (Civil)/ Superintending Surveyor of Works (Civil) and Sh. Sanjay Saxena, Superintending Engineer (Civil)/ Superintending Surveyor of Works (Civil) shall hold the Current Duty Charge to the posts of Chief Engineer-I and Chief Engineer-II respectively in Irrigation & Flood Control Department, in addition to the duties already assigned to them as SSWs, in terms of provisions contained under FR-49 (v).

While holding the post of Chief Engineer-I and Chief Engineer-II on Current Duty Charge basis respectively, Sh. O.P. Srivastava, Superintending Engineer (Civil)/S.S.W (Civil) and Sh. Sanjay Saxena, Superintending Engineer (Civil)/S.S.W (Civil) will exercise only the Technical and Financial powers and perform other non-statutory/routine duties of the post of Chief Engineer as per CPWD Manual/Code. However, all the Administrative and Statutory Powers to the post of the Chief Engineer as the Disciplinary Authority/ Appellate Authority/ Revisionary Authority under the CCS (CCA) Rules, 1965 and the powers of Head of the Department of Irrigation and Flood Control Department under the Delegation of Financial Powers and Rules (DFPR) will be exercised by the Secretary (I&FC) till the posts of Chief Engineers are filled on regular basis.

On their appointment as Chief Engineer, on CDC basis, the work allocation shall be as under:-

Further, Shri O.P. Srivastava, SSW-I in the capacity of Chief Engineer (Zone-I) on CDC basis will co-ordinate with I&FC Secretariat and various other Department/ Agencies/ Local Bodies of Govt. of NCT of Delhi and Govt. of India for all affairs of the I&FC Department.

No additional pay/ remuneration shall be admissible to Sh. O.P. Srivastava, Superintending Engineer/ SSW and Sh. Sanjay Saxena, Superintending Engineer/ SSW for holding the Current Duty Charge of Chief Engineer, Zone-I and Chief Engineer, Zone-II respectively irrespective of the duration of the additional charge, as provided under FR-49 (v).
