**OFFICE ORDER**

Competent Authority is pleased to grant 1<sup>st</sup> financial up-gradation to the following IT Cadre Officer, on the recommendation of the Screening Committee constituted for grant of financial up-gradation under Assured Career Progression (ACP) Scheme to the eligible Asstt. Programmer, Group 'B' Gazetted of IT/EDP/ Cadre of Govt. of NCT of Delhi in accordance with the instruction contained in the O.M No. 35034/1/97-Esst. (D) dated 09.08.1999 of Govt. of India, Ministry of Personnel, Public Grievances & Pensions (Department of Personnel & Training) after considering all the facts and circumstances of the case as well as observations/suggestions of the Finance Department and Services Department, Govt. of NCT of Delhi, reviewed the **Order No. 01/2010 dated 06/04/2010** and unanimously recommended that Sh. S.K. Verma, Asstt. Programmer may be granted 1<sup>st</sup> Financial Upgradation under ACP Scheme in the pay scale of Rs. 8000-13500 (pre-revised) with effect from the 31/05/2007 i.e. the date when the anomaly has arisen which has placed him in disadvantageous position viz a viz his junior (Sh. Parveen Kumar Gupta, Asstt. Programmer) and in pursuance of Dy. Secretary (ITCCU) order No. 27/2017 issued vide No.F. 13(1)/2013/ITC/5128-32 dated 29.11.2017 as per the details given below:

The order No. 01/2010 dated 06/04/2010 stands modified to the extent cited above. The officer concerned may be allowed to exercise his option, if any, under FR-22 within one month of the issuance of the order granting the financial upgradation under the Assured Career Progression Scheme (ACPS).

However, the grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a later stage the same will be recovered from their pay.
