ORDER

Whereas, the Anand Niketan Co-operative Housing Society Ltd. Anand Niketan, New Delhi-110021 is registered with this department at Regn. No. 1527/SW under the provisions of DCS Act and Rules.

And whereas, Major Gen. (Retd.) W.S. Chona, Sh. Narsing Awatar, Sh. Prem Nath Nag, Col. P.L. Kapoor (Retd.) members of Anand Niketan Co-operative Housing Society Ltd. alleging that no resolution regarding charging of Watch & Ward has been approved by the General Body Meeting held on 28.08.1994 and Managing Committee of Society is charging Watch & Ward without the approval of General Body Meeting. Further, there has been gross violation in accounts of society. The auditor has not taken the steps to follow the correct accounting procedures.

And whereas, a complaint dated 11.01.2016 received by this office was as serious nature and the same was examined and a Show Cause Notice under Section 61 (1) of DCS Act, 2003 was issued to the President/Secretary of the society on 11.04.2016 to explain the reasons on the aforesaid issues, why inspection under section 61 of DCS Act, 2003 shall not be conducted

And whereas, the representation and submission were filed by both the parties and it has been observed that both parties have made allegation and counter allegations. Further, in their respective submission/replies, there were contradictory statements against each other. In order to establish the truth, it is hereby concluded that this can be done only through proper inspection as per provisions of Section 61 of the DCS Act, 2003. It was considered and decided to initiate the inspection under section 61 of the DCS Act, 2003.

Now, the Competent Authority is pleased to appoint Sh. Vijendra Kumar, Dy. Commissioner (Transport), as Inquiry Officer of the Anand Niketan Co-operative Housing Society Ltd. U/s 61 of DCS Act, 2003, to make an inspection on complaint dated 11.01.2016 and submit the report within 60 days. He will be paid Rs. 15,000/- (Rupees Fifteen Thousand Only) as honorarium from the society fund for this purpose.

This issues with the approval of the Registrar Co-operative Societies.
