Director (SCP), Deptt, for the \welfare of SC/ST/DBC/Minorities', as Inspecting Officer of the OCS Friends Cooperative Group Housing Society Ltd New Delhi-110021, U/s 61 of DCS Act. 2003, to make an inspection on complaint dated 24.04.2015 and 18.04.2015 and submit the report within 60 days. He will be paid Rs. 15,000/- (Rupees Fifteen Thousand Only) as remuneration from the society fund for this purpose.
