**ORDER**

Whereas an appeal dated 17.03.2016, has been filed by the Appellant against the Managing Committee of the society for non-furnishing of the information asked vide application dated 01.02.2016 u/s 139 of DCS Act, 2003.

Whereas notices were issued to both the parties to appear before the Appellate Authority on 25/04/2016, Sh. K.D. Golani, President of the society and appellant Sh. D.S. Kundu were present. Reply submitted by the society was not appropriate; hence society was directed to provide the parawise information to the appellant within 15 days.

Whereas the society failed to comply the order dated 20/05/2016. Further, Show Cause Noticed dated 25/10/2016, 09/12/2016 & 30/01/2017 under Rule 165 of DCS Rule 2007 was issued vide which Society was asked to show cause as to why the penalty may not be imposed under rule 165 of DCS Rule 2007 for non-furnishing of the information u/s 139 of the DCS Act, 2003.

Whereas this was clear that the society is not inclined to provide the information sought by the appellant, hence the undersigned issued Show Cause Notice to President/Secretary of the Society for having violated the Provisions of section 139 (2) of the DCS Act, 2003. Asking them as to why the penalty of Rs. 250 per day should not be imposed upon them.

Accordingly, there has been blatant disobedience of order dated 20.05.16 of the Appellant Authority by the Society. Therefore, in exercise of powers conferred u/s 139 (2) of DCS Act 2003 r/w Rule 165 (8) of DCS Rules 2007, I hereby impose a penalty of Rs. 10,000/- on the Information Officer Sh. K.D. Gulani of Philips CGHS Ltd., Dwarka for non compliance of the above stated order. This penalty shall be

deposited from the personal pocket of the concerned Information Officer in the Cooperative Education Fund of the office of Registrar Cooperative Societies, Delhi within a period of 15 days of receipt of this order and submit the deposit receipt in this office. Further, the President of the above said society is directed to furnish the information free of cost as sought by the appellant in his RTI application dt. 01.02.2016 within a period of 2 weeks from the receipt of this order.

The appeal is disposed of accordingly with the above observations.
