ORDER

Whereas, the Nav Sansad Vihar CGHS Ltd, Plot No 4, Sector-22, Dwarka, Delhi-110075, is registered with this department at Regn. No. 965/GH under the provisions of DCS Act, and Rules.

And whereas, Sh. G.S. Kapila, SSP (Retd.) CBI, has conducted an inquiry under the provision of Section-59 (1) of DCS Act, 1972 and submits its report on 31.01.2007, which was considered by this department and the inquiry officers was requested on various occasions to give an additional report on the matter regarding calculation/arriving at an approximate assessment of the less caused/pecuniary advantage obtained by different Managing Committee members during the relevant period, so that this office may be able to know about the percentage of requisite recoveries to be effected from the concerned/individual executive members of the Managing Committee of the aforesaid society in individual case, but till date no communication has been received in the matter. Now, it has been informed on 28.04.2017, that Sh. G.S. Kapila is not residing at the given address.

Now, therefore, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi in exercise of the power vested in her under DCS Act & Rule is pleased to appoint Sh. P.C. Jain, DANICS, Spl. Director (WCD) as Inquiry Officer of the Nav Sansad Vihar CGHS Ltd., u/s 59(2) of DCS Act. 1972, to conduct the detailed investigation in Nav Sansad Vihar CGHS Ltd. and further directed to submit the inquiry report within one month from the date of receipt of orders. He shall be paid a consolidated remuneration of Rs.15,000/- (Rupees Fifteen Thousand only), to be paid out of society fund.
