**ORDER**

Whereas Rajyasabha Secretariat Employees CGHS Ltd., Plot No. 4, Outer Ring Road, Pitampura, Delhi-110034 is registered with this department as per DCS Act/Rules and as per by laws of the society vide registration No. 174(GH.)

Whereas the General Election of The Managing Committee of Rajyasabha Secretariat Employees CGHS Ltd., Plot No. 4, Outer Ring Road, Pitampura, Delhi-110034 was held on 17.05.2015.

And, Whereas, in award of Arbitration case No. 07/GH/DR/ARB/14-15 dated 10.03.2016, whereby election of four members to previous Managing Committee was declared as null and void, resulting in Managing Committee was left with only two valid members. Further, in Special General Body Meeting held on 03.04.2016 wherein resolution has been passed to go for fresh election.

Whereas in his report Sh. M.L. Gupta has submitted that he has issued the Agenda Notice for Election, but No nomination received on date scheduled for the purpose.

Whereas as Sh. Prashant Kumar, SDM (Karol Bagh) was appointed as Administrator vide this office order No. F.47/AR-II/147/GH/RCS/2017/39-42 dated 23.01.017 wherein Sh. Prashant Kumar shows his inability to perform his duties.

in exercise of power vested in U/s 3S(5) of DCS Act, 2003 the Competent Authority (Registrar Cooperative Societies New Delhi) is pleased to appoint Sh. Nand Kishore, Dy. Registrar, DTU at B-908, Navnirman CGHS Ltd., Plot No. 6-A, Sectoar-2, Dwarka, New Delhi-110075 as Administrator Cum Returning Officer to manage the affairs of the society and to conduct the election of the Managing Committee of the society i.e. Rajyasabha Secretariat Employees CGHS Ltd., Plot No. 4, Outer Ring Road, Pitampura, Delhi-110034.
