OFFICE ORDER

Hon'ble Lt. Governor, Delhi on file No.F.47/86/Policy/2009/RCS dated 29/9/2011 has granted approval to regularize the draw of lots of 26 societies under DCS Act.

It has been observed that a number of cases for clearance of Membership through Rule 90 Committee and Regularization of left out cases of self draw Societies are pending with various Housing Sections.

In order to expedite the clearance of pending cases, a new section has been created in the name of **Housing Section -09**. The existing Housing Sections shall provide the list of pending cases for clearance of membership through Rule 90 Committee as well as regularization of draw of lots of 26 self draw societies including those societies which might have conducted Self draw before 2010.

In view of the above, the work allocation amongst the ARCS and transfer/posting of officials is reorganized with immediate effect and till further orders. Files pertaining to Housing Section- 09 shall be monitored by Sh. Lekh Raj, DANICS/DRCS and shall be sent to RCS through Spl.RCS :-


