NOTICE U/S 20(5) OF DCS ACT, 2003

for the dissolution & deleting the name of the society from this department.

Whereas, the Jaina CGHS Ltd. Plot No.26, Sector-13, New Delhi-110085 was registered vide No.381/GH with this department under the provision of DCS Act/Rules & bye-laws of the society. On perusal of the records of the society, it is revealed that the society has not complied with the various provision of DCS Act & Rules, which are as under:-

- 1) The society has not submitted the Annual Return u/s 32 of DCS Act, 2003 since for the last so many years.
- 2) Annual Audit of the books of the accounts of the society has not been done/report submitted to this office by the society for the Co-operative year(s) 2001-02 onwards.

And whereas, keeping in view the provisions of section 20(5) of DCS Act,2003 this Department has reasons to believe that your co-operative society has not carried on business for the last 15 years; hence lying defunct and serving no useful purpose to its members in particular and the co-operative movement in general as well.

And whereas, as per section 20(5) of DCS Act, 2003 society is treated as deemed dissolved if, audit of last 15 years has not been conducted as the society has not got audited its books of account as per record available, hence no assets and liabilities.

Now, therefore, you are hereby required to intimate/inform this office whether the co-operative society is carrying on business in accordance with the DCS Act & Rules. The reply alongwith the supporting documents must reach this office within 15 days from the issue of this letter, failing which further action u/s 20(5) of DCS Act,2003 will be initiated against the society for the dissolution of the society and deleting the name of the society from the Register of co-operative societies.
