**ORDER**

Whereas, IES Officers Co-operative Group Housing Society Ltd. is registered vide registration No. 782/GH with this department under the provisions of DCS Act & Rules framed there under;

Whereas, a complaint of Sh. A.K. Panda members, regarding request for intervention of RCS solicited u/s 61 of DCS Act, 2003 to settle the issues relating to stilt parking.

Whereas, the matter was examined by this office and observed that inspection of records of the society to be carried out to bring out the factual truth of the matter.

Whereas, as per section 61 of DCS Act 2003, Registrar may upon receipt of a serious complaints made by a member or a public servant in writing about the affairs of the cooperative societies or the Committee, The Registrar Cooperative Society appoint an Inspecting Officer to conduct detail investigation in the affairs of the society.

Now therefore, I Jitendra Kumar Singh Assistant Registrar (Section-III) hereby conveys the approval of Competent Authority to appoint Sh. Dinesh Kochaar, Under Secy. NITI Aayog, Government of India, as Inspecting Officer under Section 61 of DCS Act, 2003. The Inquiry Officer shall have access to all books, accounts, papers, vouchers, securities, stock and other property of that society and may, in the event of serious irregularities discovered during inspection, take into custody and shall have power to verify the cash balance of the society.

Further, the society shall pay consolidated amount of Rs. 15,000/- (Rupees Fifteen Thousand Only) as re muneration to I.O. from the fund of the society for conducting the inquiry. The inquiry shall be completed within a period of 60 days of issue of this order.
