ORDER

This order shall dispose off the appeal filed by Sh Siddharth Bansal, Appellant in respect of RTI Appeal in ID No. 548 u/s 19 of RTI Act, 2005. Notices were issued to both parties for appearing on 17.10.2017. The appellant present and PIO present.

The appellant who appeared stated that he is not satisfied with the reply given by PIO Section 2, Section 3 and PIO/Assistant Programmer. The point numbers 1 to 5 (point no. 5 Members list) of RTI ID No. 548 dated 21.06.2017 relates to Section 2, the SPIO who appeared submitted that the appellant may inspect the concerned file, identify the information and obtain the same after depositing requisite fees at the rate of Rs. 2/- per page. Therefore, as regard point numbers 1 to 5 (point no. 5 Members list) the appellant is advised to inspect the concerned file within 15 days after issuance of order and obtain the identified documents after depositing requisite fees i.e, at the rate of Rs. 2/- per page.

As regard, point number 5 (Audit Details 2011-2017) of RTI application the SPIO (Audit) submitted that he will furnish information within two weeks to the appellant. Therefore, PIO (Audit) is directed to supply the information as regard point number 5 (Audit Details 2011-2017) of RTI application to the appellant within two weeks. As regard, point number 6 of RTI application the PIO/Assistant Programmer has already supply the information vide letter no. 1(167)/RCS/Comp-CC/2011/1334-1335 dated 28.07.2017. The appellant stated that he has filed two appeal applications vide dated 14.07.2017 and 20.07.2017 both are two different appeals for the same RTI ID No. 548.

The appeal is disposed off accordingly.

If the appellant is not satisfied with the order of First Appellate Authority then he may file second appeal before Second Appellate Authority i.e, Central Information Commissioner, August Kranti Bhavan, 2nd Floor, Bhikaji Cama Place, New Delhi – 110066.
