ORDER

Whereas, NZPH Railway Employees CGHS Ltd., Plot No.7, Geeta Colony, Delhi-110031 is registered with this Department vide Regn. No.507/GH.

Whereas, as all the members of Management Committee had submitted their resignations as members of Management Committee of NZPH Railway Employees CGHS Ltd.

Whereas, Sh. T.K. Jain (Retd. DANICS) vide order dated 21.07.2017 was appointed as Administrator-cum-Returning Officer of the NZPH Railway Employees CGHS Ltd. u/s 35(5) of DCS Act 2003 to manage the affairs of the society and to hold the election of the Managing Committee. Whereas, now vide letter dated 03.11.2017, has requested to appoint a new Administrator.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoints Sh. Pritam Singh (Retd. Adhoc DANICS) as Administrator-cum-Returning Officer in place of Sh. T.K. Jain in the NZPH Railway Employees CGHS Ltd. under section 35(5) of DCS Act, 2003, to manage the affairs of the Society and hold the election of the Managing Committee of society within Ninety (90) days from the date of appointment. The Administrator, on expiry of the period of 90 days will not exercise any financial powers till the term is further extended by the competent authority. An honorarium of Rs.10, 000/- (Rs.Ten Thousand Only) per Month will be paid to him from the society funds.
