ORDER

Whereas, Nav Sena CGHS Ltd., Plot No. 9, West Enclave, Pitam Pura, New Delhi-110034 is registered with this Department vide Regn. No.294/GH.

Whereas, Sh. R.C. Gupta, Ex. VATO was appointed as Administrator in the society vide this office order dated 22.04.2015 to manage the affairs of the society and to conduct election and audit of the society and Sh. R.C. Gupta, Administrator in the Nav Sena CGHS Ltd. tendered his resignation dated 11.07.2017.

Whereas, Sh. Deepak Kumar, AERO (AC-07 Bawana) was appointment as Administrator-cum-Returning Officer U/s 35(5) of DCS Act 2003 in place of Sh. Ramesh Gupta, Ex-VATO in Nav Sena CGHS Ltd. vide this office order no. F.47/249/GH/Sec-5/652-654 dated 21.08.2017.

Whereas, Sh. Deepak Kumar, Administrator-cum-Returning Officer tendered his resignation as Administrator-cum-Returning Officer of Nav Sena CGHS Ltd. citing heavy work load in AC-07, Bawana, and expressed his inability to give proper time to the affairs of the society.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoints Sh. Paras Nath Yadav, Accounts officer, F&W Department, as Administrator in the Nav Sena CGHS Ltd. under section 35(5) of DCS Act, 2003, to manage the affairs of the Society and hold the election of the Managing Committee of society within Ninety (90) days from the date of appointment. The Administrator, on expiry of the period of 90 days shall not exercise any financial powers till the term is further extended by the competent authority. An honorarium of Rs.10, 000/- (Rs.Ten Thousand Only) per month will be paid to him from the society funds.

This issues with the prior approval of the Competent Authority.
